Legal basis for data processing

Your data is being processed on the basis of Sec. 6 (1) (f) of the General Data Protection Regulation.

Your personal data will be disclosed to

- c) reporting about the Ceramics Market and its relating programme in advance as well as retrospectively.
- d) providing pictures and text material for reporting about the Ceramics Market and its related programme in advance as well as retrospectively.
- e) informing about the participating ceramics artists and their contact details.

Duration of storage of personal data

After collection, your personal data will be stored until further notice for the purpose of re-

contacting as well as documenting the International Ceramics Market Siegburg in the long term.

Rights of data subjects

According to the General Data Protection Regulation (GDPR), you are entitled to the following rights:

- When your personal data is being processed, you are entitled to request information on the personal data stored (Sec. 15 GDPR).
- Should the personal data processed be incorrect, you are entitled to have them corrected (Sec. 16 GDPR).
- If the legal requirements are satisfied, you may request deletion or restriction of the processing as well as object to the processing of personal data (Sec. 17, 18 and 21 GDPR).
- If you consent to the processing of data or there is a contract on the processing of data, and the data is being processed by automated means, you also have the right of data transferability (Sec. 20 GDPR).
- In the event you exercise said rights, the public institution will review whether the legal requirements for this are satisfied.
